Payment :We ask for a 25% non refundable deposit and the balance to be paid not less than four weeks from date of arrival. We do not accept credit cards so payment should be made by cheque. If final payment is not paid by the due date (please note that we do not send out reminders) we reserve the right to cancel the booking. In the event of a duplicated booking, we reserve the right to offer equal or better accommodation to the client or a refund of the monies paid. Our liability is limited to that offer only.

The property is offered with all heating, lighting, electricity, bed linen and towels included.

- 1) There is ample parking available and guests are requested to drive slowly and carefully as there are children playing in the grounds; all children should be supervised as this is a working farm. Parking is at the risk of the guests using it.
- 2) No liability is accepted for damage or loss of property during your stay. Please ensure your car is locked and that the property is secured when you go out.
- 3) There are two hot tubs for the convenience of guests and notes for guidance are displayed alongside.
- 4) Any furniture, fittings or equipment moved during your stay must be returned to their original position prior to departure. All damage must be reported and paid for prior to your leaving.
